2. **NO ARTICLES** (candy, gum, trinkets) **WILL BE THROWN FROM A FLOAT OR VEHICLE PARTICIPATING IN THE PARADE. THIS WILL BE ENFORCED BY THE CITY POLICE DEPARTMENT.**
3. **Drawings of floats must be submitted with entry form.** No float may be changed once the entry form has been submitted, unless approved by the Buggy Days Committee.
4. Each and every unit must furnish at least one identification of professional quality and readable from a distance. All bands must be appropriately uniformed.
5. All vehicles must be convertibles. No enclosed cars are permitted, unless antique. No pick-up trucks, unless pulling a float or antique. All drivers of vehicles must be 16 years or older and have a valid driver's license.
6. Walking or drill units are not allowed to stop and perform. **ALL UNITS MUST BE IN CONSTANT FORWARD MOTION AT ALL TIMES.**
7. Children under 12 years of age must be accompanied by an adult
